- Speaking in respectful tones and refraining from the use of vulgar or derogatory language or other inappropriate behavior
- Resolving conflicts in a respectful, honest and caring manner
- Respecting the property of others
- Creating a safe environment free of weapons, alcohol and/or drugs
- Reporting to a YMCA staff person any suspicious or inappropriate behavior

Adherence to the Code of Conduct is essential. Noncompliance may result in suspension or termination of membership privileges and/or use of the facility.

WAIVER: In consideration of gaining membership or being allowed to participate in the activities and programs of the YMCA and to use its facilities, equipment, and machinery; in addition to the payment of any fee or charge, I do hereby waive, release, and forever discharge the YMCA and its officers, agents, employees, representatives, executors, and all others from any and all responsibilities or liability for injuries or damages resulting from my participation in any activities or my use of equipment or machinery in the above mentioned facilities or arising out of my participation in any activities at said facility. I do also hereby release all of those mentioned and any others acting upon their behalf from any responsibility or liability for any injury or damage to myself, including those caused by the negligent act or omission of any those mentioned or others, acting on their behalf or in any way arising out of or connected with my participation in any activities of the YMCA or the use of any equipment at the YMCA. I agree to adhere to all policies set by the YMCA as written in the YMCA Membership Handbook. Cancellation notice must be given by the 25th of the month prior to ensure completion by the 1st.

Terms and Conditions

1. Monthly membership dues, including the capital improvement fee, are required to be paid by the 1st of every month. Late or non-payment can result in the YMCA cancelling my membership.

2. I understand that if I wish to terminate or change my membership in any way, I must give the YMCA written notice by the 25th of the month. I understand that I must turn in all of my membership cards upon termination and that I will receive temporary cards for the balance of the time I have paid for or will be paying for.

3. The YMCA Board may, at its discretion, adjust the monthly rate applicable to my membership category once per year. I understand that I will receive notice prior to any such change in my membership fees.

Should any membership deduction not be honored by my bank for any reason, I realize that I am still responsible for the payment, plus a return payment fee of \$30.00 or the maximum amount allowed by law. This is in addition to any service fee my bank may make. I understand that it is my responsibility to notify the YMCA in writing should I change my financial institution and/or account at any time. This service fee may be adjusted by the YMCA without notice.
